Course Overview

- **IOSH** is the Chartered body for health and safety professionals. With more than 47,000 members in over 130 countries, they are the world's largest professional health and safety organisation. IOSH was founded in 1945 and is a registered charity with international NGO status.
- **IOSH Managing Safely** was developed to enable managers and supervisors in any organisation to introduce new controls and implement changes within their department. The course equips leaders to promote a safer workplace in line with their company's own policies and wider health and safety regulations.

Course Objectives

Upon the completion of the course, delegates will be able to:

- Appreciate the importance of managing safely.
- Recognise common workplace hazards and implement appropriate control measures.
- Estimate, evaluate and reduce risk by applying a hierarchy of risk control.
- Understand both personal and corporate responsibilities relating to health and safety.
- Undertake structured risk assessments and accident investigations.
- Recognise different ways to measure and improve health and safety performance.
